Police Information

### Theft by Deception – Retail Theft

At approximately 1700 hours on 9/28/2007 Abington Police arrested four suspects who were committing a return scam at Macy's in Willow Grove Park Mall. Two of the suspects selected merchandise and piled it on a display bed and placed an empty cart next to the bed. They left the area and the other two suspects retrieved the merchandise, placed it in the cart and took it to a register stating that they had purchased it and wanted to return it. Because they did not have receipts, they were given a gift card for the value of the merchandise. The suspects had in their custody numerous gift cards from Kohls, T.J. Maxx, and other stores. Some of these had receipts wrapped around them indicating that they were from stores in Christina, Delaware. It is believed that these gift cards were obtained from merchandise return scams similar to the one they were arrested for in Abington. All gift cards and receipts were seized as evidence.

These suspects have no reliable local address and claim to be in the area to attend a funeral. They claim to be staying in room 339 at the Red Roof Inn, 415 Stanton Christiana Road, Newark, Delaware 19713. Intelligence indicates that they are Scottish Travelers who travel frequently between Delaware and Florida and various other locations. When first arrested they spoke in a cant which they claimed was Gaelic. The suspects were arrested, charged with criminal conspiracy, retail theft, theft by deception, receiving stolen property and are currently being held at Montgomery County Prison in lieu of \$50,000 cash bail. They traveled to Willow Grove Park Mall in a black Ford F150 pickup truck with New Mexico registration HNA079. This vehicle is registered to Justin Hinderliter of PO Box 784, Portales, New Mexico 88130. Abington Police have seized this vehicle until ownership can be established.
